- Subject Matter Expert for the daily maintenance and operation of general office space, laboratories, and cGMP manufacturing factories.
- Engineering resource for the Metrology group. SME for clean and base building instrumentation.
- SME oversight of the CMMS Work Order system to be used for documenting facilities request as well as triaging and compliance leveling of requested work.
- Oversee the daily operations of the facilities team operations including process mechanics, utility and HVAC mechanics, and cleaning.
- Maintain the effectiveness and operational monitoring of the cGMP manufacturing facility including, manufacturing clean suites, storage, labs, and mechanical and utility space.
- Coordinate the service and maintenance of plant utility systems including process gasses and water, HVAC, solvent distribution, plant steam, electrical, waste streams, and other site utilities.
- Provide supervision, training, and guidance to the facility mechanics.
- Responsible for 24/7 utilities operations and production support on the manufacturing plant.
- The position will grow to Head of ICM Facilities Maintenance and Metrology for both the Woburn and Devens location.
